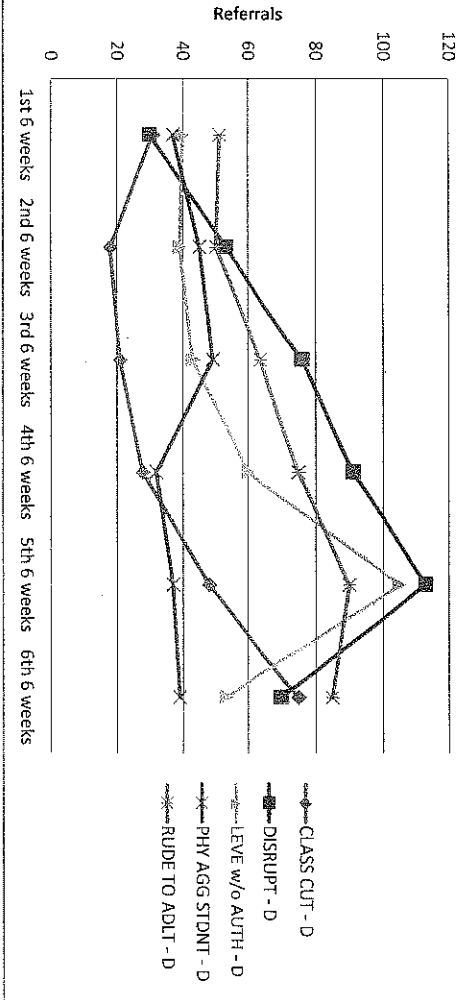

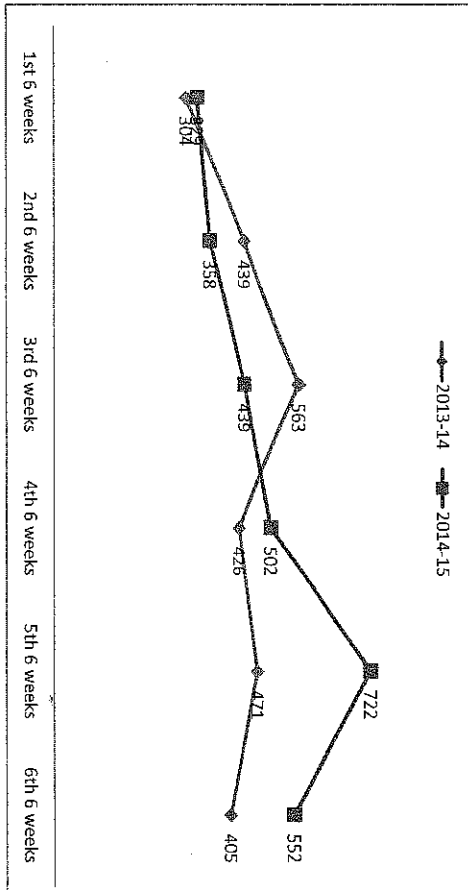

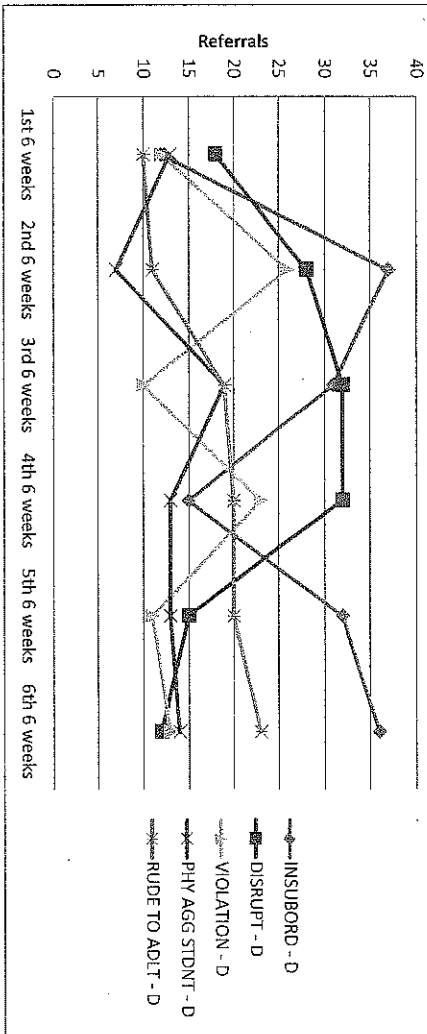
Top 5 Referrals by Type 2014-15 Burnet



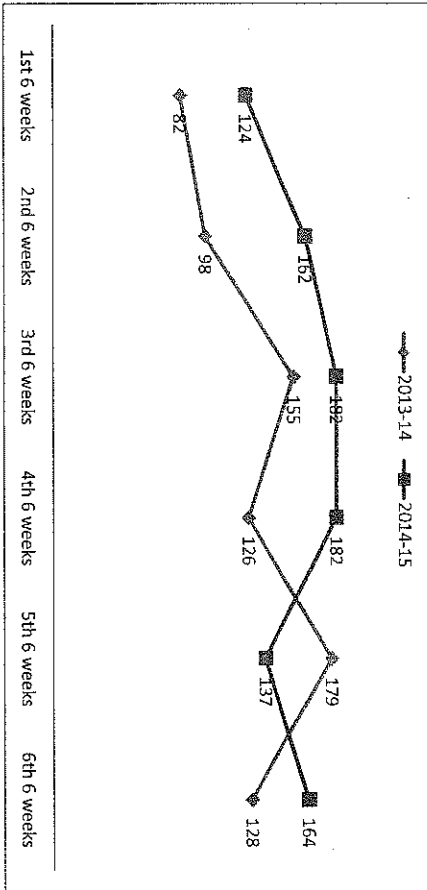
Burnet Total Referrals

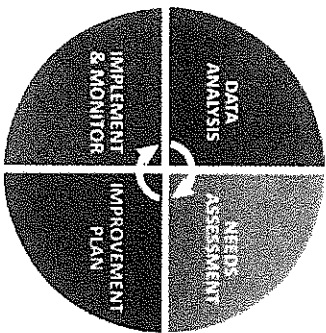

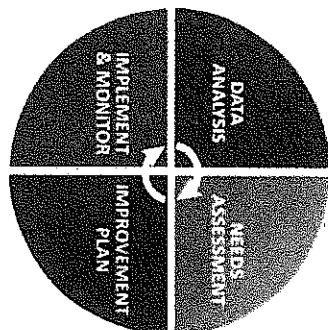
